Re: A call for the investigation, indictment and prosecution of those responsible for the funding, research, development and release of the biological viral pathogens known as SARS-CoV-2 AND the contaminated genetic vaccines produced by Pfizer and Moderna.

Dear Secretary of HHS Mr. Robert F. Kennedy, Jr..

I am the Plenipotentiary of the Slovak Republic Government charged by Prime Minister Mr. Robert Fico with the Review of Management Processes and Resource Allocation During the COVID-19 Pandemic. I am also a member of the Government of the Slovak Republic and a Member of the National Council.

I was the sole representative of the only country that rejected the IHR regulations and opposed the WHO's efforts to centralize power and I work under the direction of the Slovakian Prime Minister. It is in this capacity that I now submit this letter to you.

In response to my directives from my Prime Minister, I have been working with Richard M Fleming, PhD, MD, JD. Dr. Fleming has provided materials, documents, video presentations, a deposition, affidavit and other evidentiary material, which I have presented to the Slovakian Council during the last year.

Dr. Fleming has provided not only detailed information about the origins of SARS-CoV-2, treatment regimens, an understanding of genetic vaccines and their implications, but he has also provided detailed information on the pathological mechanisms of action of the S-protein, both from the SARS-CoV-2 viruses and the genetic vaccines. All of which have been accurately detailed and described by Dr. Fleming, for which I and the people of Slovakia, and I dare say the world, owe him a huge debt of gratitude. His work honors your country.

Dr. Fleming has also established the adverse InflammoThrombotic and Prion effects of adding the COVID vaccines directly to human blood, in addition to microscopically demonstrating contaminants within vaccine vials; contamination which demonstrate criminal and civil liability under U.S. Strict Product Liability law. The proposed presumption of potential DNA contamination of the genetic vaccines had not previously been unequivocally confirmed by any government.

Accordingly, I was directed, on behalf of the Slovakian government, to obtain multiple genetic vaccine vials, including the Pfizer and Moderna vaccines, and submit them directly for further testing and

analysis. The results of the analysis, determined by Sona Pekova, MD, PhD, of the Czech Republic were confirmed by Dr. Fleming, showed BOTH mRNA (expected) and DNA within the genetic vaccines.

None of the manufacturers have declared DNA content as a component of their COVID vaccines. The high amounts of DNA present in the samples tested exclude the possibility of simple contamination occurring during the manufacturing process; rather, they are consistent with an intentional and knowing inclusion.

High DNA contamination of vaccines pose an extremely high potential risk of incorporation of genetic information into human DNA and the possible development of cancer by influencing the activity of 9-pathways outlined by Dr. Fleming including tumor-suppressor genes.

Dr. Fleming has provided a substantial amount of material to U.S. Attorney General Pamela Jo Bondi via USPS. The material was received by the Department of Justice on 3 March 2025 and includes not only Dr. Fleming's materials but materials of 9-other experts including affidavits.

As the Plenipotentiary and a member of the Slovakian Government, I presented Dr. Fleming's materials along with the results of the research findings of Dr. Pekova this morning 13 March 2025 to Slovakian President Peter Pellegrini and Attorney General Maroš Žilinka.

I have also provided Dr. Fleming a copy of the media presentation discussing the results of Slovakia's investigation of the Pfizer and Moderna COVID vaccines, which can be found on the www.10Letters.org website under the "Slovakia Call to Action" tab where it can be seen by people in Slovakia, the United States and all other countries.

In preparations for my presenting this material to the President and Attorney General of Slovakia, as Plenipotentiary for Slovakia, I feel compelled to submit this material directly to you, to be included with Dr. Fleming's submission and to call upon you to *investigate, indictment and prosecution those responsible for the funding, research, development and release of the biological viral pathogens known as SARS-CoV-2 AND the contaminated genetic vaccines produced by Pfizer and Moderna.*

Accordingly, I am presenting this material directly to you and ask that you work directly with U.S. AG Pam Bondi and FBI Director Kash Patel on this investigation. I look forward to hearing back from you in my official Slovakian capacity.
